THIS CONTRACT IS FOR THE PURPOSES OF PROVIDING RELIABLE, COST-EFFECTIVE COVID-19 TESTS FOR USE IN STATEWIDE TESTING EFFORTS. A SUFFICIENT NUMBER AND DIVERSITY OF COVID-19 TEST TYPES IS NEEDED TO ENSURE CAPACITY AND MAINTENANCE OF TESTING SUPPLY RESERVES FOR SURGE MITIGATION PLANNING. TESTS MAY BE USED TO SUPPORT TESTING EFFORTS IN FIXED OR MOBILE COMMUNITY-BASED TESTING SITES ACROSS 24 JURISDICTIONS INCLUDING RURAL AND FRONTIER AREAS. THESE SITES MAY BE RUN BY THE STATE AND/OR LOCAL HEALTH DEPARTMENTS OR IN PARTNERSHIP WITH OTHER STAKEHOLDERS.

PURSUANT TO THE STATE FINANCE AND PROCUREMENT ARTICLE, SECTION 13-110 OF THE ANNOTATED CODE OF MARYLAND, EXCEPT AS PROVIDED IN (B) THE FOLLOWING ENTITIES MAY PURCHASE MATERIALS, SUPPLIES, AND EQUIPMENT UNDER IS CONTRACT:

BOARD OF EDUCATION OR IS ACCREDITED BY THE ASSOCIATION OF INDEPENDENT SCHOOLS; AND

(II) IS EXEMPT FROM TAXATION UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE; OR

SUCH CASES, THE PRODUCT REQUEST WILL BE OFFERED TO THE NEXT LOWEST-PRICED CONTRACTOR THAT MEETS THE PRODUCT REQUEST NEEDS.

#### ELECTRONIC TRANSACTION FEE:

1) CONTRACTOR SHALL PAY AN ELECTRONIC TRANSACTION FEE TO THE STATE IN THE AMOUNT OF ONE PERCENT (1%) OF THE TOTAL CONTRACT SALES. THE ELECTRONIC TRANSACTION FEE IS CALCULATED BASED ON ALL SALES TRANSACTED UNDER THE CONTRACT, MINUS ANY RETURNS OR CREDITS.
