LOTTERY PLAY CENTERS -

FLOOR MODEL. APPROXIMATE OVERALL SIZE 24-26 INCHES WIDE BY 16-24 INCHES DEEP BY 75-75 INCHES HIGH. TO BE CONSTRUCTED IN MOLDED POLYETHYLENE WITH MINIMUM 8-10 INCH DEEP X 24-26 WIDE WRITING SURFACE FOR SUPER ABRASIVE RESISTANT PLASTIC. AN ADDITIONAL WRITING SURFACE SHALL BE PROVIDED, WHICH MEASURES NO MORE THAN 36 INCHES FROM THE FLOOR AND 8-10 INCHES DEEP X 24-26 INCHES WIDE IN ORDER TO COMPLY WITH ADA (AMERICANS WITH DISABILITIES) REQUIREMENTS. BASE UNIT SHALL BE BLACK WITH LOTTERY LOGO ON FRONT; ARTWORK WILL BE SUPPLIED. BASE ALSO HAS STORAGE UNIT APPROXIMATELY 18-24 INCHES IN HEIGHT AND 10-14 IN WIDTH. THE SHELVES SHALL BE APPROXIMATELY 6 1/2 INCHES IN WIDTH. BASE UNIT SHALL INCLUDE LEVELING GUIDES AND BE COUNTER BALANCED FOR STABILITY.
